- 1. The above-referenced Master Declaration of Covenants (herein referred to as "Declaration") is hereby amended in accordance with the terms set forth in this First Amendment.
- 2. Article I, Section 1 is hereby deleted in its entirety and replaced with the following:
 - **Section 1.** "Association" shall mean and refer to Southbridge Plat 1 Owners' Association, Inc., its successors and assigns, a non-profit corporation organized pursuant to Chapter 504 of the Code of Iowa, 2019, as amended. The Articles of Incorporation and initial Bylaws for the Association are hereby incorporated by this reference.

 - <u>Section 6 Title to Outlots</u>. The Declarant hereby covenants for itself, its successors and assigns, that it shall convey Outlot "Z" to the Association, free and clear of all mechanic's liens or any liens or encumbrances whatsoever except covenants, easements, conditions and restrictions created by this Declaration or granted to any public authority. In the event additional outlots are established on any portion of the Properties, Declarant shall convey the outlots to the Association, free and clear of all mechanic's liens or any liens or encumbrances whatsoever except covenants, easements, conditions and restrictions created by this Declaration or granted to any public authority.
- 4. Article V, Section 3 is hereby deleted in its entirety and replaced with the following:
 - <u>Section 3.</u> Declarant is and shall be responsible for all duties and obligations of the Association hereunder and shall have all rights of the Association until the Association is established and the initial Common Areas are conveyed thereto.
- 5. The legal description on Exhibit "A", is hereby deleted in its entirety and replaced with the following:
 - Lots 1 through 121 and Outlot Z in Southbridge Plat 1, and Official Plat, Adel, Dallas County, Iowa.
- 6. All other terms, provisions, and conditions original set forth in the Master Declaration remain effective and binding upon the Declarant.
